## WARNING!

### **ALL INDIVIDUALS ENTERING THE FACILITY AND/OR PARTICIPATING IN SANCTIONED ACTIVITIES MUST COMPLY WITH THIS DECLARATION**

The Lunenburg Yacht Club (The "Organization") requires the disclosure of exposure or illness in order to safeguard the health and safety of all participants and limit the further spread of COVID-19. This Declaration of Compliance will be kept safely, and personal information will not be disclosed unless as required by law or with your consent.

I, the undersigned being the Parent/Guardian (the "Individual") of the Participant(s) named above do hereby acknowledge and agree to the terms outlined in this document as it pertains to myself and the Participant(s):

- 1) The coronavirus disease COVID-19 has been declared a worldwide pandemic by the World Health Organization and COVID-19 is extremely contagious. The Organization has put in place preventative measures to reduce the spread of COVID-19 and requires all persons to adhere to the compliance standards described in this document.
- 2) The Individual and the Participant(s) have not at any time been diagnosed with COVID-19; OR if the Individual or the Participant(s) were diagnosed with COVID-19, they were cleared as non contagious by provincial or local public health authorities. Should the Individual or Participant(s) be diagnosed with COVID-19 at any time they are to be cleared as non contagious by provincial or local public health authorities prior to returning to the Organization.
- 3) The Individual and Participant(s) are attending or participating voluntarily and understand the risks associated with COVID19. The Individual and Participant(s) agrees to assume those risks, including but not limited to exposure and being infected.
- 5) The Individual or Participant(s) have not, nor has anyone in their contacts, experienced any signs or symptoms of COVID-19 in the last 14 days (including fever, new or worsening cough, fatigue, chills and

body aches, respiratory illness, difficulty breathing, nausea, vomiting or diarrhea, pink eye, or loss of taste or smell).

6) If the Individual or Participant(s) experiences, or if anyone they contact, develops any signs or symptoms of COVID-19 after submitting this Declaration of Compliance, the Individual or Participant(s) will immediately isolate, notify the Organization, and not attend any of the Organization's facilities, activities, programs or services until at least 14 days have passed since those symptoms were last experienced or until cleared as non contagious by provincial or local public health authorities.

7) The Individual or Participant(s) have not travelled to, had a lay-over in or had contact with anyone who travelled to any country outside Canada, or in any province outside of Nova Scotia, New Brunswick, Prince Edward Island or Newfoundland in the past 14 days. If the Individual or Participant(s) travel outside of Nova Scotia, New Brunswick, Prince Edward Island or Newfoundland or had contact with anyone who travelled outside of Nova Scotia, New Brunswick, Prince Edward Island or Newfoundland after submitting this Declaration of Compliance, the Individual or Participant(s) will not attend any of the Organization's facilities, activities, programs or services until at least 14 days have passed since the date of return until this requirement is waived by provincial health authorities.

8) The Individual and Participant(s) are following recommended provincial health guidelines, <https://novascotia.ca/coronavirus/> , including but not limited to maintaining separation of 2 metres (six feet) when required by provincial health guidelines, adhering to recognized hygiene best practices, and otherwise limiting exposure to COVID-19.

9) The Individual and Participant(s) will follow any specific protocols implemented by the Organization.

10) The Individual and Participant(s) will bring their own personal items and personal equipment (such as water bottles, bags, towels, PFD etc.) at their discretion and will not share their personal items or equipment with other individuals.

11) This document will remain in effect until the Organization, per the direction of the provincial government and provincial health officials, determines that the acknowledgements in this Declaration of Compliance are no longer required.

12) The Organization may remove the Individual or Participant(s) from the facility or from participation in the activities, programs or services of the Organization at any time and for any reason if the Organization believes, in its sole discretion, that the Individual or Participant(s) is no longer in compliance with any of the standards described in this document.
